Fellows are selected for their scholarship, leadership, and commitment to practicing in the field of nonprofit law.

Attached are the materials necessary to complete a Fellowship application. All application materials are due on Monday, December 10, 2018. Finalists will be notified and interviews will be conducted in January 2019.

At least one reference should be from a Law School Professor.
