

FORD FOUNDATION FELLOWSHIP IN NONPROFIT LAW

2023-2024 Application Procedure

The Ford Foundation Fellowship in Nonprofit Law permits one Fellow each year to spend a year in residence at the Ford Foundation's Office of Legal Services in New York, working with the General Counsel and staff of attorneys. Fellows are selected for their scholarship, leadership, and commitment to practicing in the field of nonprofit law.

Attached are the materials necessary to complete a Fellowship application. All application materials are due on **Tuesday, November 1, 2022**. Finalists will be notified and interviewed in November 2022.

A completed application consists of the following items:

- Fellowship Application
- Official Law School Transcript, **sent directly** from law school's registrar
- Resume
- Two Letters of Recommendation **sent directly** to ncpl.info@nyu.edu from any:
 - Law School Professor
 - Former or Current Employer

At least one reference should be from a Law School Professor.
