

FORD FOUNDATION FELLOWSHIP IN NONPROFIT LAW

2023-2024 Application Procedure

The Ford Foundation Fellowship in Nonprofit Law permits one Fellow each year to spend a year in residence at the Ford Foundation's Office of Legal Services in New York, working with the General Counsel and staff of attorneys. Fellows are selected for their scholarship, leadership, and commitment to practicing in the field of nonprofit law.

- Resume
- Two Letters of Recommendation **sent directly** to ncpl.info@nyu.edu from any:

 - Former or Current Employer

At least one reference should be from a Law School Professor.
